4 The period for which personal data will be retained

The controller will keep the personal data for as long as necessary. The longest the controller will keep personal data is 3 months.

5 How the personal data will be processed and preserved?

Personal data will be processed:

machine (automated) through computers and computer programs;

in written form;

6 Data subject rights, information and access to personal data

As a data subject, I have the right to **access, rectify or delete my personal data** or **restrict processing**. I have the right to request information on **what personal data is processed** and the right to request **an explanation regarding the processing of personal data**.

I also have the right to object **to processing**, as well as the right to **data portability** (i.e. the right to obtain personal data concerning me that I have provided to the controller in a structured, commonly used and machine-readable format, see Article 20 of the GDPR for more details).

I have the right **to withdraw my consent at any time**, without prejudice to the lawfulness of processing based on consent given before its withdrawal, if the processing is based on Article 6(1)(a) or Article 9(2)(a) GDPR. This means that I do not have such a right, in particular if the processing is necessary for compliance with a legal obligation that applies to

the administrator is subject to (in particular the obligations relating to the LVTČ).

As a data subject, I have the right to request information about the processing of my personal data, which the controller is obliged to provide to me without undue delay. The content of the information is determined by Article 15 of the GDPR. The controller has the right to charge a reasonable fee for providing the information, not exceeding the costs necessary to provide the information.

As a data subject, I have the right to contact the controller or the Office for Personal Data Protection if I have any doubts about compliance with the obligations related to the processing of personal data.

The controller declares that the processing **does not involve automated decision-making**, including **profiling**, as referred to in Article 22(1) and (4) of the GDPR.

The controller declares that personal data are not processed for scientific or historical research purposes or for statistical purposes.

The controller declares that it will process the personal data:
